Athina Tatsioni, MD, graduated from the Medical School of the University of Ioannina in Greece. She has been a Board-certified physician for General Practice /Family Medicine. Dr Tatsioni completed her PhD thesis under Professor John Ioannidis' supervision in the Department of Hygiene and Epidemiology in the Medical School of the University of Ioannina. She has also worked at the Evidence-based Practice Center at Tufts-New England Medical Center as a postdoctoral research fellow for 2 years. Since 2005, she has been an Assistant Professor of Medicine (adjunct) at Tufts University School of Medicine in Boston, USA.

In 2009, she was appointed initially as a lecturer and then as an Assistant Professor (2013) in the Faculty of Medicine in the University of Ioannina in Greece. Since 2019, she has been an Associate Professor and Head in the Research Unit for General Practice /Family Medicine and Primary Health Care in the Faculty of Medicine of School of Health Sciences of the University of Ioannina in Greece.

Since 2009, Dr Tatsioni has been involved in organizing and teaching the course "General Practice /Family Medicine" in the undergraduate medical students in the University of Ioannina including communication skills, diagnosis and treatment guidelines in primary health care, prevention, integrated care of the elderly, integrated care of patients with multiple morbidity and multiple medications, and palliative care in primary health care. She has also participated in teaching research methodology for post-graduate MSc programs in several universities in Greece including Ioannina, Crete, Thessaly, and the Aristotle University of Thessaloniki. Since 2009, she has been National Representative for Greece in European General Practice Research Network (EGPRN).

Dr Tatsioni's major research interests include evidence quality assessment, evidence synthesis methodology (systematic reviews, meta-analyses), diagnostic technology assessment methodology, comparative effectiveness methodology, and clinical decision in primary health care. Dr Tatsioni has performed a number of studies focusing mainly on empirical evaluation of published literature, systematic reviews and meta-analyses. She has coauthored systematic reviews and meta-analyses on a broad range of clinical subjects and methodological issues, which have been published in peer-reviewed journals. Currently, she has 77 publications in international peer reviewed journals that have received more than 2200 citations, and an hindex 23. She is the supervisor for four PhD students and collaborates with a number of additional researchers and faculty members in Greece and abroad.
